2. Deposit of earnest money of Rs.25,000/- in the shape of demand draft in favour of the Drawing and Disbursing officer, District Food & Supplies and Consumer Affairs Officers, U.T. Chandigarh before participating in auction.
3. The vehicle will be sold to the highest bidder.
4. Highest bidder will have to remove the vehicle on his own cost within three days after deposition of full payment otherwise parking charges shall also be levied @1000/- per day.
5. Highest bidder shall have to submit his/her Photo identity proof of residence (Aadhar Card, Voter Card, Pan Card or any other authentic proof) to the department before taking away the vehicle.
6. Department reserves the right to accept or reject the highest bidder without giving any reason.
7. The earnest money deposited before start of the auction shall be adjusted with balance amount of highest bid.
8. Earnest money deposited before start of auction shall be returned back to other bidders except highest bidder after the auction is completed.
9. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Aadhar Card, Voter Identity Card in case of individual and Registration Certificate in case of firms etc.)

The successful bidder will also be responsible in for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously and will be responsible for any misuse accident related to the vehicle if used prior to transfer of registration.
