In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with letter No. 11(9)/2014-ECR&E, dated 02.09.2014 of the Deputy Secretary, Government of India, Ministry of Consumer Affairs, Food and Public Distribution, New Delhi and, in concurrence of the Removal of Licensing Requirements, Stock Limits and Movement Restrictions on Specified Foodstuffs (Fourth Amendment) Order, 2017 issued by the Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs), vide notified Order S.O. 3136 (E), dated 27.09.2017, the Administrator, Union Territory, Chandigarh is pleased to notify the extension of stock limits on Edible Oils and Edible Oil seeds upto 30th September, 2018. The prevailing stock limits on Edible Oils and Edible Oil Seeds in U.T., Chandigarh are as given below:-

1. Stock of Edible Oils and Edible Oil Seeds

Sr. No.	Type of Business	Edible Oils	Edible Oil Seeds
1	Dealers- including Wholesalers, Distributing Agents, Selling Agents or such persons	700 Qtls.	1,000 Qtls.
2	Retailers	25 Qtls.	100 Qtls.
